I fully understand that this activity involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, my own inactions, others participating in the event, the conditions in which the event takes place, or the negligence of the "releases" named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, costs and damages I incur as a result of my participation in the activity.

REBALL RULES AND REGULATIONS:

1. All players must sign a waiver. Players under the age of 18 must have their waiver signed by a parent or legal guardian.
2. Protective masks must be worn at all times while participating in Reball.
3. Reballs may not be fired at any time other than during game sessions. Guns must be pointed at the ground during all breaks in game play.
4. All equipment must remain on the field at all times. This includes Reball guns, Reballs, and any other equipment associated with Reball.
5. Reballs may not be shot within 20 feet of participants.
6. Players may only enter the field at the Field Referee's signal between games. Field entrance doors must remain shut during all game play. Doors may only be opened by a referee in-between games sessions.
7. Players may not point guns or shoot at the ceiling, walls, or towards the spectator area. Goals Indoor Sports has a zero tolerance policy and players will be removed from the field immediately.
8. Any personal guns to be used on the field need to be checked by the Field Referee prior to entering the Field (guns must shoot below 220fps to be allowed on the field).
